It is mandatory for all students to have **German health insurance**.

- ✓ We CANNOT enrol you without a German health insurance confirmation.
  - o If you don't hand in your health insurance documents early (best: 6 weeks) before the semester start (01.10. winter semester/ 01.04. summer semester), we cannot guarantee to get your semester ticket (free public transport) in time.
- ✓ There are several **statutory health insurance companies** in Germany, and it is your choice where you become a member.
- ✓ We are glad to let you know that we have trusted partners at BARMER health insurance and also at Techniker health insurance.

- ✓ An easy way to obtain all the necessary visa documents within a few days are service providers such as <u>AllyWays</u> (BARMER's partner and <u>Expatrio</u> (TK's partner).
- ✓ Both provide an all-inclusive package with German health insurance and blocked account as well as free travel insurance.
- \* For **a blocked account**, we haven't had the best experiences with Coracle and Instarem.
- ✓ We had good experiences with Deutsche Bank and Sparkasse.



#### **PRIVATE HEALTH INSURANCES**

- recommend it. Your chosen private health insurance needs to be checked by a statutory health insurance company (e.g. BARMER or TK) if it is sufficient for student health insurance requirements. The statutory health insurance company will then hand out an exemption from the statutory health insurance for students ("Befreiung von der KVdS") to you. Please hand that exemption and the documents from the private health insurance in at the student service.
- Please note, that your private health insurance needs to include the following services to get fully accepted.
  - ✓ No benefit restrictions in terms of a maximum reimbursement of expenses
  - ✓ General treatment of alcohol-, drug- or other addiction diseases and resulting treatments like rehab and detoxification
  - ✓ Treatment of long-term diseases (e.g. HIV, MS, cancer) that occurred before the start of the health insurance

## 5 steps for a perfect start

There are only a few things that are absolutely indispensable when you're new in Germany as a student. This brochure walks you through them step by step and tells you where to go to get what you need.

### Step 1: Your health insurance

First of all you need to be registered with a German health insurance company. This is necessary because you will need valid health insurance for enrolment at university and for a visa from the "Ausländerbehörde" (foreigners' registration office). Our advice is to get in touch with your personal BARMER contact to make the application process as fast and as convenient as possible.

## Step 2: Your enrolment

Once you have registered with a German health insurance, you are allowed to enrol at university. It is essential to take out health insurance before enrolment. Without confirmation of membership, enrolment is not possible. Our confirmation of membership is accepted at all universities in Germany. On receipt of confirmation of enrolment, you will need to send it to your health insurance.

## Step 3: Appointment with the foreigners' authority

For non-EU citizens: For your appointment with the **Ausländerbehörde**, you will need confirmation of enrolment and confirmation of health insurance.

### Step 4: Your social security number

Maybe you are considering a side job during university? The HR office of your company will need a German social security number. It is important in order for you to get paid! BARMER will apply for that number on your behalf within a few days.

## Step 5: Your bank account

Last but not least, if you don't have a European bank account, it's advantageous to find a bank in Germany without fees.





## **Special benefits**
